



Bragg Gaming Group Prize Competitions

Terms & Conditions

1. The Promoter

The promoter is: Bragg Gaming Group, Inc., a Canadian Corporation, having a registered address of 130 King Street West, Suite 1955, The Exchange Tower, Toronto, Ontario M5X 1E3, Canada.

2. The competition

- 2.1 The tournament will be held between Wednesday, the 27th of September (12:00 CET) and Friday, the 29th of September 2023 (12:00 CET).
- 2.2 The title of the competition is Sum of Wins (Blitz tournament)
- 2.3 How much can you win within 100 rounds?

Players confirm their participation by pressing JOIN within the tournament widget and by playing at least 1 qualifying round within the game Mystery Mine. Each blitz round the player is given a countdown of 100 rounds to score the best result possible for the leaderboard.

Players compete based on the sum of wins scored during the blitz round's 100 spins (each 1 BGG won = 1 point for the leaderboard). The 3 players with the highest scores win the main prizes.

Please note: Only bets with a value of up to 2 BGG (the default bet size of the slot) count as QUALIFYING ROUNDS for the tournament. Bets with a higher value will not be counted for the blitz round countdown and the wins made with them will not contribute to your overall score on the leaderboard.

Each player may retry the challenge up to twice after finishing their 100 spins. The player will be notified of their available retries once all their spins are used through an in-game pop up and will be able to try again by pressing RETRY within the tournament widget.

Keep in mind: Retrying the blitz challenge resets the player's available spins back to 100 and removes the previous score from the leaderboard. Only the player's latest attempt qualifies for the leaderboard.

3. Personal data processing

We require your consent to process personal data for the purposes of the competition. By pressing JOIN you consent to the processing of the following data: username, name of the company you work for, date of birth, player ID, game-play data, amount of prizes won, transaction account number (in case the prize is paid out in real money), tax number (in case needed to report the win to tax authorities). Data will be processed to display the top-players during the competition, to determine the winner of the competition, to pay out the prize, to publish the name of the winner of the competition and to satisfy any regulatory requirements (such as to report the amount of win to tax authorities in case required). Promotor is the controller of personal data. Data will be kept for 2 years or longer as required in line with

applicable legislation (such as tax). More information on how Promotor processes personal data is available at <https://playground.bragg.group/privacy-policy>.

You can withdraw your consent to personal data processing at any time by contacting us at privacy@bragg.group, whereby you will not be able to participate in the competition if your consent is withdrawn.

4. Terms applicable

- 4.1 By pressing JOIN within the tournament widget, you are agreeing to be bound by these terms and conditions. The tournament is also governed by Terms and Conditions for the Use of Bragg Playground (<https://playground.bragg.group/terms>), which are incorporated into these terms by reference and form an integral part of these terms.

5. Eligibility

- 5.1 The competition is open to registered users of Bragg Playground aged 18 years or over (or other age of majority in line with the law of player's country of residence), **except:**
 - a. employees of the Promoter or its holding or subsidiary companies;
 - b. residents of any country or jurisdiction where the competition may breach any local law or regulation; or
 - c. members of the immediate families or households of (a) above.
- 5.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.
- 5.3 The Promoter will not accept competition entries that are automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications).
- 5.4 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
- 5.5 Competition entries cannot be returned.

6. The prize

- 6.1 The 3 best players who score the highest result on the leaderboard will take home the main prizes:
 1. prize: 300€
 2. prize: 200€
 3. prize: 100€

The main prizes will be e-mailed to the winners in the form of a virtual prepaid Mastercard. Once activated it can be used for online purchases. The prepaid card is available in Euros, USD and GBP value of the prize in EUR.

- 6.2 Additionally, a 10% royalty discount for the game Mystery Mine shall be awarded to the Promoter's business partner the player is representing (hereinafter: the partner) of the 20 highest-ranking players on the leaderboard. The royalty discount can be applied on a preferred starting date chosen by the partner for a duration of 14 days. To apply the royalty discount the partner needs to confirm their preferred time frame of the royalty discount with their dedicated account manager. The royalty discount shall be applied only once per partner. The completion of the quest by multiple players of the same partner will not result in an increase or a repeat of the royalty discount.
- 6.3 The prize is not negotiable or transferable.

7. Winners

- 7.1 The results of the competition are final, and no correspondence or discussion will be entered into.
- 7.2 The Promoter will contact the winner personally as soon as practicable after the end of the competition, using the email address provided at the time of the user registration at Playground.
- 7.3 The Promoter will publish the username and employer of the winner at the following website: <https://playground.bragg.group/>. The publication on the website shall be deleted at the latest after 18 months of its publication.
- 7.4 If you object to any or all data, such as your username, employer or winning entry, being published, please contact the Promoter at privacy@bragg.group. In such circumstances, the Promoter must still provide the information and winning entry to the competent authorities on request.

8. Claiming the prize

- 8.1 Please allow 30 days after the winners have been contacted for the delivery of the prize.
- 8.2 The prize may not be claimed by a third party on your behalf.
- 8.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available (does not respond to the email notifying the winner of the prize), the Promoter reserves the right to offer the prize to the next eligible entrant.
- 8.4 The Promoter does not accept any responsibility if you are not able to take up the prize.
- 8.5 The winners are responsible for determining their tax obligations and for the payment of taxes and charges applicable when receiving/using the prize.

9. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize. Your statutory rights are not affected.

10. General

- 10.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the competition.
- 10.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
- 10.3 These terms and conditions are governed by English law. If any entrants to this promotion wish to take court proceedings, then they must do this within the courts in the United Kingdom.
